The Certification Body requires the Holder of the Certificate to keep records of all the complaints and corrective actions applicable to the products covered by this Certificate.

Certificate validity is conditional to consistence of the manufacturing method with the established factory production control system and to observance of the conditions of a contract for surveillance of the products being placed on the market.

The inspection period is one year.
